**FINANCIAL REPORT:**

- General spending is at 53% and revenue is at 103%. Highway spending is at 50% and revenue is at 108%.
- NYCLASS - is at 2.7% and rising.
- State revenue came in as budgeted.
- CHiPS and PAVE-NY monies came in.
- Budget Public Hearing will be November 7<sup>th</sup> at 5:30 PM.
- Three budget transfers:
  - o \$7,000 from Contingent to Contractual-workshops (\$600), Contractual-trees (\$1,100), Workers' Comp (\$300) and Hospital & Medical (\$5,000).
  - o \$1,200 from Surplus to Joint Youth.
  - o \$500 from Dog Control and \$700 from Celebrations to Joint Youth (\$1,200).

Motion by Mrs. Foster, seconded by Mr. Conway, to approve budget transfers. Motion PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster.

- Mr. Bobbette received a check from the school district for fuel reimbursement in the amount of \$502.85.
- Mr. Bobbette discussed the timing of purchasing new equipment.
