FIRST PUBLIC HEARING open at 6:45 PM

Motion by Mr. Schlicht, seconded by Mrs. Foster, to open the Public Hearing at 6:45 PM. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

Local Law #3 of 2021: Solar Energy System - There was a question about the zoning and how that would be handled so that there would not be solar panels all over the countryside. Mr. DeMore and Mrs. Vilardi explained how we will be implementing an “overlay” district to address that concern and keep the beauty of the landscape in the Town. REGULAR TOWN BOARD MEETING

The Regular meeting was called to order by Mrs. Vilardi at 7:02 PM.

Mr. DeMore brought the SEQR form for Mrs. Vilardi to read and the Board to answer. Motion by Mrs. Foster, seconded by Mr. Conway, to appoint the Town Board as Lead Agency.

FINANCIAL REPORT:

- Quiet month, but overall very good. General spending is at 58% and Highway spending is at 36%, revenue is at 110%.

- Budget transfer for \$1,000 from State Retirement to Workmens' Compensation (\$500) and Unemployment Insurance (\$500). Motion by Mr. Schlicht, seconded by Mr. Brown, to authorize the budget transfer. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Foster, Brown, Schlicht.

ZONING REPORT:

- No report.

HIGHWAY REPORT:

- Mr. Virgil submitted two checks from the Fire Department (\$105.33 and \$242.24) and one from the school district (\$397.82) for fuel reimbursement.
- He received \$22,885.00 for the sale of the pick-up.

HISTORIAN:

- No report.

HISTORICAL SOCIETY:

- Ms. Beglinger announced we will not be merging with the Pompey Historical Society, but will have joint programs.
- Last week she was asked to open the Pioneer Museum for the Boy Scouts and Girl Scouts spending the weekend at the Pines Camp. In all, there were 30 visitors.
- Ms. Beglinger noticed the names of three County politicians in the guest book. Mrs. Vilardi was accompanying them at Highland Forest looking at the camps and they decided to visit the Museum.
- Year to date, there have been 281 visitors.

NEW BUSINESS:

Toggenburg Mountain Sale: Mrs. Vilardi and Mr. DeMore met with someone interested in buying Toggenburg. They are interested in having a microbrewery, zipline and live outdoor concerts. It is currently zoned as non-conforming use and would need to be re-zoned as agricultural or residential.

OLD BUSINESS:

Community Development: The County Executive approved the Fabius Main Street project grant for a total investment of \$222,551. He also approved the grant for the Highway Garage in the amount of \$100,000.

Highway Garage Addition: The engineers gave a quote for a 10,000 sf building, at \$250/sf which would be about \$2.5 million to build a new Highway Garage. This doesn't seem feasible for a town our size. The Tully Highway Garage cost \$3.2 million and the Amish-built Highway "garage" in Otisco only cost \$650,000, but they have no ventilation, among other things. Mrs. Vilardi suggested everyone give it some more thought and see if there is a more affordable alternative.

Fabius Evergreen Cemetery: Ms. Beglinger reported their current bank balance is \$6,553.85.
