FINANCIAL REPORT: Onondaga County was made whole on property taxes from the Town. There are three budget transfers:

- From General Fund Surplus for \$134,000 to Engineering (\$23,000) and Garage (\$111,000).
- From Highway Fund Surplus for \$26,000 to General Repairs for \$26,000.
- From Highway Fund Machinery (\$280,000) and Bridges (\$75,000) to Surplus for \$355,000. Motion by Mr. Brown, seconded by Mr. Conway, to approve the budget transfers. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Foster, Brown, Schlicht.
