Motion by Mr. Schlicht, seconded by Mrs. Foster, to approve the minutes of the last meeting. Motion PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Brown, Schlicht, Foster.

FINANCIAL REPORT: The Town property taxes have been collected in full. The first ½ of the snow and ice removal money has been received from the County, earlier than usual. The 2020 Annual Financial reports for Youth and the Town are filed with the Town Clerk. Motion by Mrs. Foster, seconded by Mr. Schlicht, to authorize the Town Clerk to place a legal notice in the paper that these reports may be viewed at her office. PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Brown, Schlicht, Foster. Mr. Chartrand distributed the assets inventory list.

ZONING REPORT: In Mr. Decker's absence, Mrs. Vilardi reported that things are starting to pick up, including a new house being built on Route 91 S.

HIGHWAY REPORT: Earth Day is April 23rd, drop off at the Highway garage. Mr. Virgil found a snow plow from Beam Mack for \$5,210. Motion by Mr. Brown, seconded by Mr. Schlicht, to approve the purchase of same. PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Brown, Schlicht, Foster. We have funding of \$125,000 from Al Stirpe's office and \$50,000 from a state grant for the Highway garage renovations. Mr. Virgil and Mrs. Vilardi visited the Otisco Highway garage to get some ideas.
