The Regular meeting was called to order by Mrs. Vilardi at 5:30 PM.

Motion by Mrs. Foster, seconded by Mr. Brown, to approve the minutes of the last meeting.
Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

FINANCIAL REPORT: No report.

HIGHWAY REPORT:

- The new loader was received today. Motion by Mr. Brown, seconded by Mrs. Foster, to declare the old loader surplus. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.
- The Town of Pitcher called and is interested in buying the old truck for \$44,500, minus the plow and wings. We were hoping to get \$25,000. Motion by Mrs. Foster, seconded by Mr. Brown, to set the residual at \$44,500 for the 2010 Mack truck. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.
- A quote for a scan tool came in at \$4,995 from Motor/F-Car and another from Morrisville Auto for \$5,450. The tool from F-Car is less expensive and offers more features. Motion by Mr. Schlicht, seconded by Mrs. Foster, to authorize the purchase of a scan tool from Motor/F-Car for \$4,995. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

ZONING REPORT: No report.

HISTORIAN: The Dam Road sign is still down. A resident called complaining about a fence and tree limbs that had fallen. Was told it is a Village issue and to contact the Mayor.

FABIUS EVERGREEN CEMETERY: The balance in the account is \$3,998.72.

The Public Hearing on Local Law #2 of 2023, Written Notice for Road Defects, was opened at 5:37 PM by motion from Mr. Conway, seconded by Mr. Brown. No comments. Motion by Mrs. Foster, seconded by Mr. Brown, to close Public Hearing at 5:37 PM. Both motions PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

NEW BUSINESS:

Justice Court Resignation: The Court Clerk, George Davenport, submitted his resignation effective April 30, 2023. He has agreed to stay on for court nights only.

OLD BUSINESS:

Intermunicipal Agreement (Swim): The Towns of Fabius, Pompey and LaFayette will be joining the Town of Tully's swim program this summer. There will be two 3-week sessions and the cost will be \$100/child. Motion by Mr. Conway, seconded by Mr. Schlicht, to authorize the Supervisor to sign the Intermunicipal Agreement. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

Motion by Mrs. Foster, seconded Mr. Schlicht, to pay the bills presented tonight. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.
