**FINANCIAL REPORT:** Interest rates are good and Highway is about 37% of budget to date. Quiet month.

**HIGHWAY REPORT** : Mr. Virgil gave the Supervisor three checks for fuel reimbursement: two from the fire department for \$84.81 and \$93.56 and one from the school district for \$478.98. They will be doing some work on the shoulders of South Street. In the next few weeks, the State will be grinding Route 80 and we will get some of the milling for our use. There will be some paving done on Stebbins Road and Daley Road, from the railroad tracks to Sky High Road.

**ZONING REPORT:** Mr. Decker received the new codes books and is now following 2020 NYS Codes.

**HISTORIAN:** No report.

**HISTORICAL SOCIETY:** No report.

**NEW BUSINESS:**

***Community Development:*** Motion by Mr. Schlicht, seconded by Mrs. Foster, to authorize the Supervisor to sign for the Community Development grant for \$62,500 for work on Markham Hollow Road. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

**OLD BUSINESS:**

***Covid:*** We will plan to have the next Town Board meeting in June at the Community Center with social distancing practices. Churches are to be opening in Phase 4 with some restrictions.

***Cemetery:*** The initial amount of \$6,000 was issued and the cemetery board is very appreciative.

***Ambulance Coverage:*** Mr. Virgil asked about the status of the Certificate of Need. Mrs. Vilardi will follow-up.
