**S.O.T.S.:** A new bid will be going out in a couple of weeks. We are currently contracted with Dependable Disposal.

**Swim Program:** We have no lifeguards and 32 students are registered. DeRuyter only has one lifeguard currently and that person will not be available for two weeks of the program. Mrs. Vilardi contacted the Town of Pompey to perhaps work something out, but their program is full.

**Tioughnioga Lake Association:** As in years past, they request the use of the swim area for summer activities. Motion by Mrs. Foster, seconded by Mr. Conway, to approve their use of the swim area. Motion PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Conway, Foster, Brown.
