The Regular meeting was called to order by Mrs. Vilardi at 7:00 PM.

Motion by Mr. Schlicht, seconded by Mr. Conway, to approve the minutes of the last meeting. Motion PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Conway, Brown, Schlicht.

FINANCIAL REPORT: Mr. Chartrand presented a budget transfer from Contingent to Traffic Control Signs in the amount of \$1,000. Motion by Mr. Conway, seconded by Mr. Brown, to authorize the transfer. Motion PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Conway, Brown, Schlicht. Thanks to Mr. David Knapp, the mortgage tax first payment amount is \$10,000, down from what we had budgeted (\$12,000).

ZONING REPORT: No report.

HIGHWAY REPORT: Mr. Virgil gave the Supervisor a check from the Fire Department for fuel reimbursement in the amount of \$191.93. He has received two quotes on a traffic LED speed sign; Crossroads Highway Supply for \$7,302.55 and J.C. Smith for \$7,500. Mr. Virgil requested the 2016 Ford F-250 pickup be declared surplus and be placed on Auctions International. Motion by Mr. Schlicht, seconded by Mr. Conway, to declare the 2016 Ford F-250 pickup surplus and authorize its listing on Auctions International, setting a residual of \$15,000. Motion PASSED – Ayes – 4, Nays – 0. Voting aye – Vilardi, Conway, Brown, Schlicht. There are drainage issues in Apulia on Route 80. After a brief discussion, it was decided it was a State issue.

HISTORIAN: No report.

HISTORICAL SOCIETY: 23 people attended the June program given by the Girl Scouts. 59 People visited the Pioneer Museum since June 5th.

NEW BUSINESS:

Solar Farm: Presentation by Emma Paolino concerning developing a 4-megawatt solar farm on property located on Route 80. Mr. DeMore had a similar law from the Town of Tully for the Board to review.
