

**Minutes of the Regular Monthly Meeting

The meeting was called to order by Mrs. Vilardi at 7:00 P.M.

Motion by Mr. Schlicht, seconded by Mr. Conway, to approve the minutes of the last meeting. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

Mr. Scott English, a local trail racer, spoke about an upcoming trail race through the Fingerlakes trail. He is hoping for about 100 participants; 75-80 have already signed up. He has obtained the proper insurance certificates and the approval of several groups including the DEC and neighbors to the racing trail.

**FINANCIAL REPORT:** •Mortgage Tax funds are in, but about \$800 short so far; interest is strong from NYCLASS.  
•The Budget Workshop will be at our September 16<sup>th</sup> meeting. Tentatively, we will hold a Public Hearing on November 6<sup>th</sup> at 6:00 PM.

**ZONING:** •Mr. Bush applied for the DEMO permit. Once that is completed, he will meet with Mr. Decker to discuss a rebuild.

**HIGHWAY REPORT :** •Mr. Virgil and Mrs. Vilardi met with a representative at the County to discuss the specs for the heating at the Highway Garage.  
• Mr. Virgil gave Mrs. Vilardi architectural drawings for the garage addition.  
• Mr. Virgil obtained three quotes for a new tamper: \$7,995 from Drumm Construction (Integra); \$13,000 from Clark; \$9,767 from Stephenson Equipment. Motion by Mrs. Foster, seconded by Mr. Conway, to rescind last month's motion and authorize Mr. Virgil to purchase the Integra from Drumm Construction. Motion PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

**HISTORIAN:** No report.

**NEW BUSINESS:**

**Justice Court:** Mrs. Johnson requested to apply for a JCAP grant to purchase special protective windows and a panic button. For the panic button, the Town would incur a monthly fee of \$30-\$40. Motion by Mrs. Foster, seconded by Mr. Schlicht, to authorize Judge Johnson to apply for the JCAP grant.

## **Community Center Painting:**

We have a quote from Mr. Steve Sommers for \$18,673.52, including scraping, repair and painting. A second quote was received from Peter Reilly for \$9,400.00, including pressure washing and painting. Motion by Mrs. Foster, seconded by Mr. Schlicht, to accept the lowest bid from Mr. Reilly. Another motion by Mr. Schlicht, seconded by Mr. Brown, to authorize Mrs. Vilardi to sign the check for payment and to authorize Mr. Foster to act as second signature. Both motions PASSED – Ayes – 5, Nays – 0. Voting aye – Vilardi, Conway, Schlicht, Foster, Brown.

***Swim Area:***

Mrs. Vilardi received a verbal request to use the swim area as a staging area for the work being done at the lake. She will obtain a written request and any applicable insurance certificates. \$7.2 million bid was awarded to work on the DeRuyter Dam.

Motion by Mr. Conway, seconded by Mrs. Foster, to pay the bills on Abstract #7 in the following amounts:
