**FINANCIAL REPORT:**

- \* We received reimbursement for the Fire Clerk's salary.
- \* The second half of the snow and ice removal funds have been received, as budgeted.

**ZONING REPORT:** There are a couple of open permits and one violation in Apulia.

**HIGHWAY REPORT:**

- \* Two fuel reimbursement checks were received from the Fire District: \$32.05 and \$102.09.
- \* All the oil and stone work is completed for the year.
- \* Received the reimbursement from Western Star for the damaged blown tire.
- \* The Fall conference will cost \$550 to attend and \$150 per night for the hotel. Motion by Mr. Schlicht, seconded by Mrs. Foster, to approve Mr. Bobbette attending the Fall conference at the mentioned cost. Motion PASSED – Ayes – 3, Nays – 0. Voting aye – Vilardi, Schlicht, Foster.

**HISTORIAN:** No report.

**EVERGREEN CEMETERY:** Ms. Beglinger reported a bank balance of \$14,895.77.

**PIONEER MUSEUM:** There have been 114 visitors to the Pioneer museum this year.
