The meeting was called to order by Mrs. Foster at 5:30 PM, with Mrs. Foster leading in the Pledge of Allegiance.

Motion by Mr. Schlicht, seconded by Mr. Powers, to approve the minutes of the last meeting. Motion PASSED – Ayes – 4, Nays – 0. Voting aye –Schlicht, Foster, Brown, Powers.

FINANCIAL REPORT:

- * NYCLASS and NBT are the same at 3.90%.
- * We received reimbursement from NYS for Justice training.
- * General Fund spending is at 65% and revenue is at 115%. Highway spending is at 69% and revenue is at 128%.
- * There are two budget transfers: \$10,000 from Contingent to Buildings and \$36,000 from Machinery to Surplus-Sale of Equipment.
- * Motion by Mr. Brown, seconded by Mr. Powers, to accept the October 2025 financial report. Motion by Mr. Schlicht, seconded by Mr. Powers, to approve the basement repairs and the budget transfers.
- Motion by Mr. Brown, seconded by Mr. Powers, to accept the bank reconciliation. Motion by Mrs. Foster, seconded by Mr. Brown, to move the general payroll to the December board meeting. Motion by Mrs. Foster, seconded by Mr. Schlicht, to pay the bills on Abstract #10 in the following amounts:

ZONING REPORT: There are several permits pending for a pole barn, shed and porch.

HIGHWAY REPORT:

- * Received \$320.47 from the school district for fuel reimbursement.
- * Price for sand and salt this season will be approximately \$58,960. Plowing has begun.
- * We have received \$7,000 from the Village of Fabius to plow their roads this winter. Mr. DeMore suggested holding the check until the Village provides a contract and it is fully signed.

HISTORIAN: No report.

HISTORICAL: Ms. Beglinger reported an orienteering group visit of 50 people at the museum.

EVERGREEN CEMETERY: Ms. Beglinger reported a bank balance of \$9,702.02.

NEW BUSINESS:

Community Center: Flooring has been replaced in the kitchen and Outreach room. The water line leak has also been repaired.
